

Lesson 4 **The Dispensation of Human Government**

We are going to review a bit on the **Dispensation of Conscience**.

God no longer spoke directly to man (as in Eden) but spoke through their consciences. God also utilized the restraint of the Holy Spirit at this time too as He strove with men (Genesis 6.3).

The Dispensation of Human Government----Genesis 8:20-11:32)

This the third dispensation is called "The dispensation of human government" because it is the age in which man was first privileged to _____ himself.

I. The New Program and the New World

At least **three things** were brought over from the dispensation of Conscience into the new age of Human Government.

1- The foundation of worship continued to be a blood sacrifice as a "Burnt-offering on the altar."

This was instituted in Genesis 3:21 and 4:4.

At least five new things were introduced with this third generation.

1- Flesh was added to man's diet. In addition to "*Every green herb*" and the fruit of the trees of the garden of Eden (Genesis 1:30 and 2:8-9). Finally, man was permitted to eat the flesh of "*Every moving thing that liveth*" (Genesis 9:3).

2- At the same time, God put the fear of man and the dread of man "*Upon every beast of the earth, and upon every fowl of the air, upon all that moveth upon the earth, and upon all the fishes of the sea*" (Genesis 9:2).

3- Capital punishment was introduced in connection with Human Government. It was God who said, "*Whoso sheddeth man's blood, by man shall his blood be shed: for in the image of God made He man*" (Genesis 9:6).

Note:

This does not mean that the individual citizen should take the law into his own hands and kill a man because that man has killed someone else.

The Mosaic law says, "*Thou shalt not kill.*" This command was given to the _____ of the citizenship, and not to those who were in authority as officers of the government and ministers of God.

A new dispensation opened with the calling of Abram, and from that time on God has been dealing with a called-out people.

Let's summarize the third dispensation of human government: Genesis 8:20 – 11:32

Background: Government is the organization of society. It has the ability to restrain people by punishing crimes (Romans 13.1-7).

The source of human corruption prior to the flood was the murder of Abel and the continued existence of Cain, As a result God determined that He would never again allow murderers to infect the rest of humanity—they were to be put to death.

Stewardship/Responsibility: The responsibilities Of man under this dispensation are indicated in Genesis 9.1-7. Mankind was to be fruitful, multiply and replenish the earth. In addition, the principle of human government was introduced.

Genesis 9.6 says: *“Whoso sheddeth man's blood, by man shall his blood be shed: for in the image Of God made he man.”* God now holds men responsible for governing other men as well as being personally responsible to God under conscience.

Judgment: Mankind failed under conscience, the restraint Of the Holy Spirit and human government. For example, God's instruction to replenish and spread out in the earth (Genesis 11.4) was disobeyed.

The Tower of Babel was the result and God's judgment was to confound mankind's speech (Genesis 11.5-7) and scatter civilization (Genesis 11.8-9).

Revelation: Human government failed, but a future Ruler is coming who will reign and make all things right in a future day.
